- \$5000 books for learning commons –Mel M motions to spend \$5000 on books for the Learning Commons. Allie seconds the motion. Vote all in favour. Motion carried.
- Circuit membership (\$125/annually) and ChatGPT pro membership (\$200/annually) – Jenn H. motion to spend \$125 on a Cricut membership and \$200 for ChatGPT pro. Simmie seconds the motion. Vote all in favour. Motion carried.
- Basketball hoops and electronic scoreboard \$1050 –Mel M motions to spend to spend \$1050 on basketball hoops and an electronic scoreboard for students. Allie seconds the motion. Vote all in favour. Motion carried.
